Whereas State Bank of India has assigned the debt due to it from Aromatic Intermediates And Chemicals (Sole Proprietor-Mr. Narendra Jayantilal Trivedi) ("Borrower") along with the underlying securities in favour of Kotak Mahindra Bank Limited ("KMBL").

Whereas, the Authorised Officer ("AO") of KMBL had issued notice dated 30.06.2011 under the provisions of Section 13(2) of the SARFAESI Act and called upon the Borrower and the guarantors to pay the amounts mentioned therein, within 60 days of receipt of the said notice.
