Whereas State Bank of India has assigned the debt due to it from Aromatic Intermediates and Chemicals (Sole Proprietor - Mr. Narendra Jayantilal Trivedi) ("Borrower") along with the underlying securities in favour of Kotak Mahindra Bank Limited ("KMBL").
