ISRAELI FORCES ENCIRCLE GAZA'S KEY CITY IN SOUTH

GAZA STRIP

ISRAELI forces were encircling southern Gaza's main city on Wednesday, battling Hamas militants through streets and buildings in some of the most intense combat of the twomonth war.

The focus of the conflict has shifted into the besieged territory's south following fierce fighting and bombardment that reduced much of the north to rubble and forced nearly two million people to flee their homes. Israeli tanks, armoured personnel carriers and bulldozers were seen on Tuesday near southern Gaza's city of Khan Yunis, forcing already displaced civilians to pack up and flee again, witnesses told AFP.

"Our forces are now encircling the Khan Yunis area in the southern Gaza Strip," Israel's army chief Herzi Halevi said late Tuesday.

Putin lands in UAE on rare trip

PRESIDENT Vladimir Putin is in the United Arab Emirates for a rare visit outside the former Soviet Union Wednesday, as Russia seeks to reassert itself on the global stage.

Isolated by the West over the Ukraine war, Putin is courting allies in West Asia, where he will discuss oil, trade and the Israel-Hamas conflict. Putin was greeted on the runway by UAE officials, Russian television showed, before heading to the presidential palace under cavalry

"Today, thanks to your posture, our relations have reached unprecedented levels," Putin told UAE President Sheikh Mohamed bin Zayed Al Nahyan on his arrival, praising high trade between the countries. Later today Putin is scheduled to travel to Saudi Arabia to meet with the kingdom's de facto ruler Crown Prince Mohammed bin Salman.
